This matter appeared on this day before the Court for PLEA. Present: ASHLEY HAMMONS, Assistant District Attorney, representing the State; PUBLIC DEFENDER'S OFFICE counsel for the defendant and the defendant.

The defendant, having been duly sworn, stated to the Court that he resides at 2531 Creswell Avenue, Apartment 35 in Shreveport, La., her birthdate is January 22, 1992 and the furthest she went in school was the 10th grade.

The Court read the bill of information, La. R.S.14:102.1a (1) c and the penalties, making the defendant aware of the possible minimum and maximum sentence to the charge in which She is pleading. The Court also informed the defendant of the plea agreement. The Court then explained to and questioned the defendant to ascertain that She knew She was waiving certain basic constitutional rights, such as Her right to be represented by counsel (a lawyer) of Her choice, or if She could not afford Her own, to be represented by court-appointed counsel at no cost to Her; a right to have a trial by a jury or judge, a right not to be required to testify against himself/herself or at all, if She does not so desire; a right to confront and



cross-examine the witnesses against Her and Her right to have compulsory process to require witnesses to testify; a right to plead guilty or not guilty; a right to appeal any conviction without cost to Her if She is indigent and to have an attorney appointed for Her without cost if She is unable to employ one. The defendant was then informed that She will be sentenced in accordance with the plea agreement made between Her attorney and the District Attorney. The Court informed the defendant if She pleads guilty the Court will not allow Her to withdraw their plea at a later date.

The Court inquired if other than the plea agreement, if any promises or threats have been made to get Her to plead guilty. The defendant and defense counsel replied there has not been any.

The defendant then withdrew Her previous not guilty plea and Plead Guilty to the amended charge of SIMPLE CRUELTY TO ANIMALS (6 COUNTS) and waived the legal delays for sentencing. The Court then asked the Assistant District Attorney to recite a brief statement of the facts for the record. Defense counsel and the defendant acknowledged that these facts are true and consistent with what they know about the case.

The Court upon recommendations of the State through the Assistant District Attorney, ASHLEY HAMMONS then accepted the plea after judicial interrogation, and being satisfied the defendant is an intelligent person, capable of understanding the nature of the charge and being fully and completely informed of Her rights finds a knowing and intelligent waiver of said rights, that there is a factual basis for the plea and that the plea is a free and voluntary plea.

The Court having accepted the defendant's plea and in accordance with the plea bargain agreement and the provisions of La. R.S. 14:102.1a (1) c sentenced the defendant for each count to serve 6 month(s) IBERIA PARISH JAIL, which the Court SUSPENDED and placed the defendant on 2 Year(s) of supervised probation under the usual and ordinary conditions of probation as provided by Code of Criminal Procedure Article 895(A) and with the following special conditions:

- 1) report to the 16th Judicial District Attorney's Probation Department within 24 hours of your plea or release from incarceration;
- 2) report monthly or as directed to probation officer and pay a monthly supervision fee of \$60.00 to the District Attorney's Probation Department to defray the cost of supervision;
- 3) pay court costs and a fine of \$500.00;
- 4) pay cost of prosecution of \$ 100.00;
- 5) perform 40 Hour(s) of community service within One (1) year from the date of your plea;
- 6) Pay \$100.00 to the Public Defender's Office;
- 7) submit to and pay for random drug screens during the term of probation at the direction of your probation officer.
- 8) remain drug and alcohol free; stay out of bars, casinos, lounges and away from illicit drug and substance abusers;
- 9) remain continually and gainfully employed, or a full time student during probation;
- 10) defendant acknowledges notice of the intent of the 16th Judicial District Attorney's Office to seek a civil money judgment in accordance with the LSA Code of Criminal Procedure Article 886.1 in the event of nonpayment of the fine, court costs and costs of prosecution within sixty (60) days of the imposition of sentence herein;
- 11) all financial obligations, unless otherwise noted

herein shall be paid in twelve (12) equal monthly installments beginning within thirty (30) days from the date probation begins;  
12) your probation can convert to unsupervised upon completion of all conditions of probation.


The Court ordered the sentences run Concurrent with each other.
